The NH Energy & Climate Collaborative

- The Collaborative provides support to help integrate efforts across the State's network of energy and climate leaders, organizations, and groups.
- Leverages opportunities and removes barriers to implementation of the most significant recommendations in the Climate Action Plan that will secure the State's energy, environmental and economic future.

Energy Efficiency and Sustainable Energy Board (EESE Board)

- Created by the NH legislature to promote and coordinate energy efficiency, demand response, and sustainable energy programs in the state
- The New Hampshire Independent Study of Energy Policy Issues - The "VEIC Study"
 - Independent Study of Energy Policy Issues conducted for the NH Public Utilities Commission (NH PUC) at the direction of the Legislature.
 - The 300+ recommendations focus on the 7 most important next steps to have a significant and lasting difference on energy efficiency and sustainable energy market development in New Hampshire.

- Local Energy Working Group
 - State-wide group providing technical support and guidance to local energy committees & commissions, municipalities, schools and others seeking to reduce energy use, energy costs and fossil fuel consumption
- Department of Environmental Services
