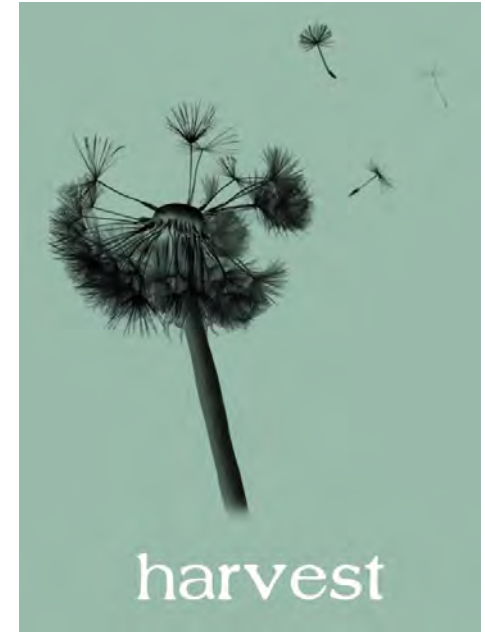
Small Grants Program

- Rolling online application
- Dedicated to help innovative, largely volunteer groups launch projects and build the group.



- \$1,000 - \$3,500
- Online application deadline: March 15 & September 15
- Dedicated to help established groups increase capacity, collaborate, and leverage impact.



- Three levels:
 - Regional Hubs
 - Capacity Building and Innovation
 - Pollinators
- Up to \$5,000
- Invitation-only

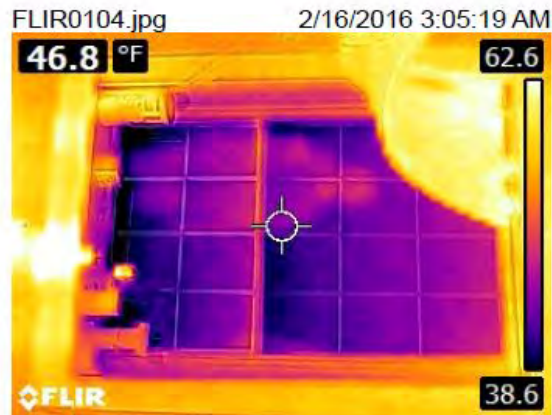
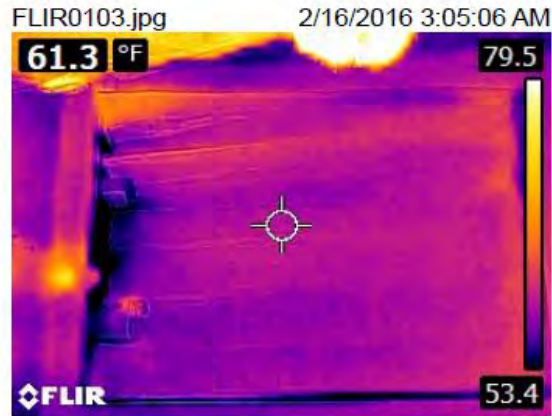

Strategic Energy Action Toolkit

Overarching Actions

Set Achievable Public Energy Goals (based on state goals if possible)

Does your group have a mission statement? Have specific energy targets/goals been set (e.g. 10% reduction in energy use in town buildings)? Do your goals line up with your state's energy goals?

Develop a List of High-Impact Projects and Prioritize Them

Be strategic about where your group focuses its energy - using this toolkit is a great start.

Assess Funding/Financing Opportunities for Energy Projects

Look broadly at the kinds of grants, funded programs, and financing opportunities available for municipal energy projects. Some opportunities may be time sensitive, so you'll want to revisit this strategy periodically.

Incorporate Local Energy Policies

Develop or Update Energy Chapter in Master Plan

Most town plans have a chapter on energy - how recently was yours updated? Check the resources section of this toolkit for tips on what should be included/updated.

Property Tax Exemption for Renewable Energy

An official exemption? An unofficial practice? Ask the local tax assessor.

Encourage Energy Code Compliance for New Construction Projects

There's a lot that towns can do to encourage local builders, homeowners, and developers to build to energy code standards. Check the Resources section for more info.

Adopt a PACE Ordinance (Property Assessed Clean Energy)

Some states have PACE programs available to help finance home energy projects, but only for residents of towns who have adopted a PACE ordinance.
